In accordance with the provisions of the KTF Constitution and the applicable election regulations, notice is hereby given that:

1. The names of all duly nominated candidates for elective positions shall be published on the official KTF website for the information of all members.
2. The publication of these names shall serve as formal notification to the membership of all valid nominations received within the stipulated nomination period.
3. **Nominations from the floor during the General Assembly shall only be permitted in instances where no candidate has been duly nominated and published on the KTF website for a specific position.**
4. Where a position has one or more duly nominated and published candidates, **no additional nominations from the floor shall be accepted.**
5. Members are encouraged to review the published list of nominees prior to the election date.
6. **All submitted nomination documents shall undergo verification by the relevant bodies involved in the KTF electoral process, including but not limited to the Independent Electoral and Boundaries Commission (IEBC), the Office of the Sports Registrar, and the KTF Electoral Committee. Only candidates who successfully meet the legal and constitutional requirements upon verification shall be included in the final list of candidates to be published.**

This notice is issued to ensure transparency, fairness, and adherence to the KTF Constitution and electoral guidelines.
